Driving a Porsche inspires an unparalleled feeling of confidence. That same emotion is behind the most important component of our Certified Pre-Owned program: the Porsche Approved Certified Pre-Owned Limited Warranty.*

Here's how the warranty works: If the qualifying Porsche Approved vehicle is purchased **while still under** the New-Vehicle Limited Warranty, the coverage is up to 6 years, or a cumulative 100,000 miles, from the original in-service date (whichever occurs first). Coverage includes:

1. Repair of defects in material or workmanship, or replacement with a new or remanufactured part.
2. 24-Hour Porsche Roadside Assistance.
3. No deductible for warranty claims.

For vehicles **no longer** under the New-Vehicle Limited Warranty

coverage at the time of used retail delivery, coverage extends until the earlier of:

- 2 years from the date of used retail delivery

or

- Up to 50,000 miles from the mileage at used retail delivery, but not to exceed a cumulative 100,000 total miles on the vehicle

Coverage includes:

1. Repair of defects in material or workmanship, or replacement with a new or remanufactured part.
2. 24-Hour Porsche Roadside Assistance.
3. No deductible for warranty claims.

This limited warranty covers all parts of the following components:

- Engine
- Fuel/cooling systems
- Powertrain/transmission
- Suspension/steering

- Brake system
- Heating/air conditioning

Vehicle eligibility

A vehicle is eligible for the Porsche Approved Certified Pre-Owned Limited Warranty Coverage if:

- The vehicle is a series production Porsche vehicle for the continental U.S. and Canada (exception: Carrera GT).
- The vehicle is less than 8 years old (96 months) from the original in-service date.
- The vehicle's mileage does not exceed 100,000 miles or 160,000 kilometers.
- All manufacturer-recommended scheduled maintenance has been done by an Authorized Porsche dealer.
- All service and recall campaigns issued by Porsche Cars North America are completed prior to delivery to the end customer.
- A vehicle history (CARFAX® or

- Experian® Auto Check®) free from negative information about the vehicle
- All identified defects were remedied during the Certified Pre-Owned inspection process and documented on a supporting repair order.

Limitations

This warranty does not cover:

- Emissions control systems and corrosion. (Refer to the Emissions Control and Corrosion Limited Warranties in the New-Vehicle Limited Warranty manual.)
- Batteries damaged from storage, lack of normal vehicle use, or non-Porsche electrical or accessory installation.
- Tires damaged by road hazard. (If you need further assistance, contact your Authorized Porsche dealer.)
- Tires damaged by premature wear.

- Parts that fail due to lack of required maintenance, or use of non-Porsche parts.
- Normal wear and tear or deterioration of any part.
- Cleaning and polishing.
- Contamination of fuels, lubricants, or other fluids.
- Lubricants and fluids, unless part of a warranty repair.
- Air conditioner refrigerant charge, unless part of a warranty repair.
- Glass breakage, chips, and/or scratches that are not due to a defect in material or workmanship.
- Appearance items that are not due to a defect in material or workmanship.
- Any car registered or normally driven outside the United States and Canada.
- The replacement of expendable maintenance items (such as spark plugs, filters, worn wiper blades, worn brakes, worn clutches, worn tires) when the replacement is not due to a defect in material or workmanship.

- The adding of any fluids unless they are needed as part of a warranty repair.
- Any car with an odometer that has been altered so that the actual mileage cannot be determined.
- Vehicles with total loss or salvage titles.
- Modifications not authorized by Porsche.
- Service adjustments (such as idle speed, air/fuel mixture, brake, clutch, headlight, and drive belts).
- Improper prior repairs.
- Abuse, accident, acts of God, competition, racing or track use, or other events beyond the control of Porsche.
- Components and/or parts that failed during racing or driving events (including Porsche-sponsored events).

Where can I buy Porsche Approved Pre-Owned Vehicles?

Porsche Approved Certified Pre-Owned Vehicles are available from participating Authorized Porsche dealers in the U.S.

Why should I buy a pre-owned Porsche from a Porsche dealer?

Nobody knows these cars better! Each vehicle is given a 111-point inspection by a trained Porsche technician and is backed by a limited warranty, Roadside Assistance, and attractive financing. Porsche Approved Certified Pre-Owned Vehicles are only available from an Authorized Porsche dealer. For peace of mind at a price that might surprise you, see your Authorized Porsche dealer or visit [porscheusa.com/cpo](https://www.porscheusa.com/cpo) to search for your vehicle.

Are all pre-owned Porsche vehicles suitable for the Porsche Approved Certified Pre-Owned program?

Vehicles eligible for inclusion may be current model-year up to no older than 8 years old from the original in-service date with less than 100,000 accumulated miles or 160,000 kilometers. In addition, the vehicle must pass a stringent 111-point inspection conducted by one of our Authorized Porsche dealers.

Who carries out the inspections?

The inspections are carried out only by trained Porsche technicians at Authorized Porsche dealers.

What does the Porsche Approved Certified Pre-Owned Limited Warranty cover?

The Porsche Approved Certified Pre-Owned Limited Warranty covers all parts in the following components and assemblies:

- Engine
- Fuel/cooling system


How long is the warranty valid?

If the qualifying Porsche Approved vehicle is purchased while still under the New-Vehicle Limited Warranty, the maximum coverage is up to 6 years/100,000 miles/160,000 kilometers, cumulative from the date the car was first delivered to the first retail purchaser, or the date it was first used as a demonstrator, lease, or company car, whichever came first.

If the qualifying Porsche Approved vehicle purchased is outside the new-vehicle warranty, the maximum coverage is 2 years from the date of used retail delivery. Or up to 50,000 miles from the mileage at used retail delivery, but not to exceed a cumulative 100,000 total miles on the vehicle.

Can I transfer the warranty?

Should you wish to sell your Porsche, you will also benefit from the Porsche Pre-Owned Limited Warranty. The remaining warranty can be transferred to the new owner.
